AALU Outlook: Wealth Tax Proposals

Strong populist streaks continue to course through the American electorate. Democratic politicians have focused increasingly on wealth inequality. Populist Republicans have generally focused more on technology and media corporations. However, numerous polls suggest populist attitudes are growing across voter demographics. A Fox News poll from earlier this year shows that 70% of Americans support raising taxes on those who make over \$10 million per year, which included 54% of Republican respondents.

On Capitol Hill, a number of new proposals to increase taxes on the wealthy have surfaced, while some Republicans continue trying to repeal the estate tax in full and index capital gains. As the Democratic presidential primary has kicked into high gear, many candidates are offering proposals to tackle inequality, and some simply find these ideas a convenient way to describe paying for other policy priorities under the rubric of 'someone else will pay.' This trend will continue.

This AALU analysis looks at the key trends driving the conversation around wealth taxes and inequality in the run-up to the 2020 election and what it means for the life insurance industry.

If you have spent time advocating on behalf of AALU with our political affairs team then you have heard about the importance of educating Members of Congress. One of the reasons we stress this so vigorously is because most Members of Congress are not life insurance experts. To understand your work and the value you deliver for your clients they need your professional expertise.

Of the 535 current Members of Congress, only 21 have any background in insurance (Life, Health, Property and Casualty, etc.) while there are 41 former mayors, 89 former Congressional staffers, and 42 former prosecutors among many others who have that background.

This data comes from the Congressional Research Service, which produces a demographic profile for each Congress, including a review of the Members' previous occupations, highlighting the professional diversity of the body. September Congressional Outlook

The legislative agenda this month will be focused on government spending bills. While the budget deal from July set the outer limits for federal appropriations, Congress still has to fill in the details. The two biggest wrinkles to getting their work done remain the debates over gun control, immigration, and the border wall. The most likely result will to be push a final decision on the spending bill until December.

AALU, working with ACLI and NAIFA, continues to advocate for enactment of the SECURE Act. We will make a major push for the bill to get passed in September, but it is a heavy lift this month.
